Resolution: The committee approved the proposal for implementation of 7^{th} CPC recommendations for revision of pay of all regular teaching & Non-Teaching staff of the University.

As per the present financial position the University is not in a position to contribute 30% or less its share for implementation of the revised pay under 7th CPC. As reported by the Finance Officer the internal revenue of the University is very meager and the said internal revenue is being utilized for other developmental activities of the University over & above the UGC Grants. It was also reported that the necessary initiative has already been taken by the University to increase its internal revenue.

Therefore, it is not at all feasible for the University to share any amount from its internal revenue for implementation of 7th CPC recommendation to its employee.

It was also decided to bring to the notice of the UGC present financial position of the University and to request UGC to kindly arrange for allocation of grant for the full amount required for implementation of the 7th CPC recommendation.
