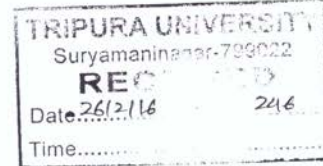

In terms of Section 15 of the NCTE Act, 1993, your Institution had submitted an application to the Eastern Regional Committee of NCTE on 08.05.2015 and hard copy received on 14.05.2015 for grant of recognition/ permission for starting B.Ed. (ODL mode) course.

2. On the basis of the scrutiny of the documents submitted by the institution, input received from the Visiting Team Report and videography, the ERC in its 203rd Meeting held on 4th - 6th February 2016 decided that the above institution has adequate financial resources, accommodation, library and laboratory as prescribed in the norms and standards and that it fulfils all such other conditions relating to infrastructural and instructional facilities required for proper functioning of the institution for a teacher education course.

3. The issuance of Formal Recognition will depend on the decision to offer one or two units. The institution is also requested to intimate the willingness in affidavit about the number of units either one or two.

4. Before grant of formal recognition under regulation 7(16) is considered, you are requested to submit the following:

- The institution is required to submit the consent/ willingness for basic unit (one/two) offering for the said course.
- The institution is required to provide safe guard for fire hazard facilities in part of the building. The documents in this regard may be submitted along with Letter of Intent.
- The institution needs to submit list of 10 schools for internship and school based activities along with the reply of 7(13) duly approved by District Education Officer.
- Faculty list approved by affiliating body after the appointment through duly constituted selection committee and ensuring compliance of NCTE norms of teaching staff etc.
- Advertisement in leading newspapers.
- Letter of University/ Affiliating Body, nominating experts/ representative for the Selection Committee.
- Minutes of the Selection Committee duly constituted as per the norms of the affiliating body.
- Approval of the University/ Affiliating body to the selected faculty in the prescribed format.
- An affidavit on Rs.100/- stamp paper to the effect that the institution has selected staff as per NCTE/ State/ University norms in the prescribed format.
- An affidavit on Rs.10/- non judicial stamp paper by the individual faculty member selected by the institution. Details should be filled in by every faculty member selected in the prescribed format.
- Educational & Professional qualification certificates of all teaching staff showing their eligibility for appointment as per the NCTE norms and experience certificate of the Principal/ HOD.
- FDRs duly converted (for a period of five years) in favour of joint name of the Society/ Trust/ Institution and Regional Director, ERC, NCTE, Bhubaneswar with Joint operation Mode: 'AND'. A letter to the concerned bank is being sent authorizing the bank on behalf of Regional Director for the conversion in the joint name.
- An undertaking from the Management of the institution as per the prescribed format available on ERC website.
- Down loaded copies of the website of the institution with the hyperlink of the same as per provisions of 7(14)(i) of the NCTE Regulations, 2014.

Admissions shall not be made until formal recognition order under Para7(16) of the NCTE(Recognition Norms & Procedure) Regulations, 2014 is issued by the Eastern Regional Committee, NCTE and affiliation is obtained from the University/ examining body concerned.

The compliance report/ reply along with documents as stated above should be submitted within **60 days** of issue of this letter, failing which appropriate action will be taken as deemed fit and proper. **However, if the institution has already submitted the reply in response to uploaded minutes of ERC in its Website, the same shall be treated as the reply to the decision of ERC.**

- (viii) That admission of students, satisfying the eligibility conditions shall be made on merit on the basis of marks obtained in the qualifying examination and/or in the entrance examination or any other selection process as per the policy of the state Government/U.T. Administration and the University.
- (ix) That there shall be reservation of seats for SC/ST/OBC other categories etc. as per the policy of State Govt.
- (x) That the supporting and other staff will be appointed as per the guidelines of the State Govt./the affiliating University.
- (xi) That the institution shall charge only such fee as prescribed by the affiliating body/State Govt. concerned in accordance with provision of NCTE (guidelines for Regulations of tuition fees and other fees chargeable by unaided teacher education institutions) Regulations, 2002, as amended from time to time and shall not charge donations, capitation fee etc. from the students.
- (xii) That the academic and other staff of the institution (including part time staff) shall be paid such salary as may be prescribed by the concerned State Govt./University from time through bank.
- (xiii) That the Management shall discharge the statutory obligations relating to provident fund, pension, gratuity etc. in respect of all its employees.
- (xiv) That the Management will make adequate funds available for providing satisfactory facilities and for proper Programme implementation.
- (xv) That the accounts of the institution will be properly maintained and audited annually by the audit authorities or a Chartered Accountant, and will be open for inspection.
- (xvi) That the Management will strictly follow all conditions and norms prescribed by NCTE from time to time, conduct the programme in all earnestness, and submit itself to inspection by the NCTE.
- (xvii) That the institution shall make the information or documents available to the NCTE or its authorized representatives as and when required by them. Failure to produce or show any of the required documents, shall be treated as a breach of the 4 conditions of recognition.
- (xviii) That the institution shall maintain records or registers and other documents etc. Which are essential for running of an educational institution especially those prescribed in the relevant norms and standards and guidelines or instructions or examining bodies.

That the institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.

In the event of non-compliance by the Tripura University with regard to the norms and standards and any other condition laid down/prescribed by the NCTE from time to time, the NCTE or a body or a person authorized by it will be free to take all necessary measures for effecting withdrawal of its recognition or permission, without consideration of any other issue, and that all liabilities arising out of such a withdrawal would solely be that of the Institution/ Management.




