To discuss the matter regarding Revised Budget Estimate for the financial year 2021-22 and Budget Estimate for the financial year 2022-23 of Tripura University.

**Resolution:** Noted and approved with 25% less in the Budget Estimate for the financial year 2022-23 under Recurring Head and subject to availability of fund. Details of Revised Budget for the financial year 2021-22 and Budget Estimate for the financial year 2022-23 are as follows:

To consider the rate of interest of General Provident Fund (GPF) payable to the GPF Subscribers.

**Resolution:** Approved. Notified rate of GPF interest by Govt. of India be paid to the subscribers if financial position permits. But, in the event of shortfall in the income earned as a result of reduced interest rates on investment, if any, the subscribers shall be paid interest at a lesser rate available from investment until the financial position of the University permits to follow the government notified GPF rate of interest.

To consider the proposal for purchase of one new Office Vehicle.

**Resolution:** Agreed. May be purchased as per the DGS&D Rate Contract with net Dealer Price of upto Rs. 4,75,000/- excluding Taxes through GeM.

To consider approval to purchase one vehicle (Bus) for students of Tripura University from Campus Development Fund (Capital Assets).


